

You may enter more than one category if eligible (see Eligibility Criteria on page 4).

How to enter

1. Determine if you are eligible to enter the Pilbara Community Services Excellence Awards
2. Complete the nomination form on survey monkey for the chosen Award Category.
3. Address the selection criteria for the chosen Category.
4. Include additional supporting information up to 10MB in size.
5. Read and accept the Declaration.
6. Attach a copy of your Certificate of Incorporation (if applicable).
7. Ensure the nomination form is approved by the Chairperson/President or authorised delegate of the organisation you are nominating or the individual you are nominating.
8. Complete and submit the nomination form on survey monkey no later than 5pm on Friday 30th August 2019.
9. Ensure you complete a separate nomination form for each category you wish to nominate for.

Come along to the Gala Dinner/Awards night on Friday 1st November at ESS Gateway Village in Port Hedland where the winners of each category announced. A Save the Date flyer will be circulated shortly.

Eligibility Criteria

To be eligible to nominate for the 2019 Pilbara Community Services Excellence Awards your organisation must meet the following criteria:

- ❖ Be a Pilbara based, not for profit Incorporated association or registered Aboriginal corporation
- ❖ Have been in operation for at least 12 months before entering your local awards.
- ❖ Meet the Judging Criteria (below) for your nominated category.

Award Category	Judging Criteria
<u>Organisation Categories</u>	
Most Outstanding Small Organisation	The organisation must employ fewer than 5 full time or equivalent staff members at the time of the application
Most Outstanding Medium Organisation	The organisation must employ between 6 and 15 full time or equivalent staff members at the time of the application
Most Outstanding Large Organisation	The organisation must employ more than 15 full time or equivalent staff members at the time of the application
Aboriginal Organisation/Corporation – Outstanding Commitment to Best Practice in Member Support and Development	The organisation must be a registered Aboriginal Corporation or Aboriginal controlled community organisation.
Outstanding Demonstration of Innovation in Collaboration	This award will be given to the organisation that has demonstrated outstanding innovation in collaboration resulting in positive outcomes for local communities
Outstanding Commitment to Place Based Services	This award will be given to the organisation that has made a difference to local communities through its commitment to place based service delivery
Excellence in Improving the health and well-being of individuals and families in the Pilbara	This award will be given to the organisation that has demonstrated excellence in the design, delivery, implementation and improvement of health services leading to measurable health and wellbeing outcomes for Pilbara communities.
Outstanding Demonstration of Leadership – Organisation	This award is open to any organisation that has demonstrated excellent leadership qualities and skills leading to an improvement in the lives of local people or communities.
Best Pilbara Organisation	The winners of the Best Community Organisation category from 2018/9 LGA and local CCI awards will be eligible for this award
<u>Individual Categories</u>	
Outstanding Demonstration of Leadership - Individual	This award is open to any individual over the age of 26 years who has demonstrated excellent leadership qualities and skills that have led to an improvement in the lives of local people or communities

Outstanding Demonstration of Leadership – Young Person	This award is open to any young person under the age of 26 years who has demonstrated excellent leadership qualities and skills that have led to an improvement in the lives of local people or communities
Outstanding Individual Contribution to Youth Well-Being	This category is open to any individual, recognised by their peers, as having made an outstanding contribution to young people achieving their full potential in areas such as education, sport, arts and culture, social and emotional well-being, employment and entrepreneurship. The nomination can be made by a community member, school or other organisation with which the person is affiliated. The nominee could be a young person or an adult.
Volunteer of the Year	This award is open to any unpaid volunteer who has made an outstanding contribution and has positively impacted the lives of others and their community
People’s Choice Awards	This award will be given to the individual or organisation with the most public votes. The organisation must have completed a submission for any of the organisation categories above to be eligible.

Tips for completing your nomination

- ❖ Try and make your nomination one that the judges will find comprehensive, informative and interesting to read.
- ❖ Once you have completed all sections, re-read what you have written to ensure you have addressed all criteria.
- ❖ Have someone from within your organisation and also a friend/colleague who knows you or your organisation to read through the submission to see if you have missed any important information. Take on all their comments.
- ❖ When writing a submission, keep the following in mind:
 - Keep it clear and concise
 - Look at the judging criteria and address each point
 - Show why you/your organisation should be the winner. What makes you special?
 - Tell a story
 - Where possible, keep the information relevant to the past year
- ❖ It is advisable to have your nomination prepared in a word document and then cut and paste into the survey monkey as you will be unable to save your work in survey monkey.
